**OWNER ACKNOWLEDGMENT OF BYLAWS, CODE OF REGULATIONS
and POSTED POOL RULES**

Each Owner, as defined in the Bylaws of Fallen Timbers Family Recreation Club, Inc. ("Bylaws"), is responsible and accountable for adherence to the terms and provisions of the Bylaws.

Each Owner shall adhere to the Code of Conduct (also referred to as Club Rules and Regulations), which may be updated by the Board of Directors from time to time and to any posted "pool rules". In addition, Owner acknowledges that any guest of Owner shall also be subject to the Code of Conduct (Club Rules and Regulations) and any posted "pool rules". Violations of the Code of Conduct (Club Rules and Regulations) and posted "pool rules" by a guest of Owner or by Owner may result in immediate removal of the guest and Owner from the facility, inability for that guest to return to the facility permanently, suspension of Owner's guest privileges and disciplinary action as described in the Bylaws.
